**TERMS:** Purchases from Mortellaro's Nursery, Inc. are due 30 days from the date of the invoice or Net due on the 10<sup>th</sup> depending on the Terms stated in the Approval Letter you will receive along with your Credit Limit. Statement will be mailed after the first of the month and it is the Purchaser's obligation to see that invoices are paid within the terms period. *If Purchaser fails to follow this policy Mortellaro's Nursery, Inc. will demand Payment on Delivery of future orders and any earned volume discounts will be forfeited.* Past due amounts are subject to a Finance Charge of 1.5% per month or such maximum lesser rate as may be permitted by law. Invoices are considered overdue 15 days after the due date. Purchaser agrees that it is bound in an individual capacity, in all respects, by the provisions of this Purchase Agreement notwithstanding the capacity in which Purchaser shall sign below.

**DELINQUENT PAYMENTS:** This agreement shall in all respects be governed by, and construed in accordance with the laws of the State of Texas. Any judicial proceedings brought against Purchaser with respect to this agreement may be brought in court of competent jurisdiction in Seguin, Guadalupe County, Texas. By execution of this Agreement, Purchaser unconditionally accepts the jurisdiction of the courts of the State of Texas. If Purchaser is not a resident of the State of Texas, service of process upon lessee by mail shall constitute sufficient notice of any such proceeding.

Statement above and below are understood to be an accurate statement of the terms and conditions of the agreement between Mortellaro's Nursery, Inc. and Purchaser. Failure to advise Mortellaro's Nursery, Inc. immediately of any discrepancies, objection to or disagreements with such terms and conditions shall be construed as an acceptance of this agreement as written.

**CLAIMS AND SHORTAGES:** All claims for any cause must be made immediately upon receipt of goods. We will not entertain claims which are filed after goods have been accepted. Purchaser acknowledges that any Person who signs the delivery document has authorization.

Special Agreements entered into with sales representative or other Company employees are not valid, unless specified by written contract prior to delivery of merchandise or performance of services.

Shipment of orders is subject to cancellation caused by governmental regulations, laws and orders. Also droughts, inclement weather; labor disputes, floods, fire, frost, embargoes or any other cause reasonably beyond the control of Mortellaro's Nursery, Inc.

All orders are accepted subject to availability of stock on hand at the time of delivery. The prices applicable for each order shall be the prices set forth in the current price catalog of Mortellaro's Nursery, Inc. at the time of shipment.

**LIMITED WARRANTY:** Mortellaro's Nursery, Inc. prides itself in exercising the greatest care in keeping our varieties true to name and warrants that the nursery stock sold is true to name as described within recognized tolerances. There are no warranties that extend beyond the face hereof, expressed or implied. Including the warranties of merchantability and fitness for particular use, and Mortellaro's Nursery, Inc. expressly is not liable for any consequential damages.

Customer's sole remedy for breach of any warrants contained herein is limited to a refund of the purchase price. Notwithstanding the foregoing, Mortellaro's Nursery, Inc. makes no warrants for loss of plants shipped.
